Ms Deanna Ong was elected to the Board of Directors of Swiss Re Asia Pte. Ltd. on 31 December 2017 and was appointed as Chair of the Board of Directors effective 1 May 2023.

Ms Ong was appointed as a Board Director of Swiss Re Ltd. on 17 April 2020. She is also a member of the Audit Committee and the Compensation Committee.

Ms Ong is Chief People Officer at GIC, responsible for Human Resource & Organization, Finance and Corporate Governance for the GIC group. GIC is a global investment management company for the foreign reserves of the Government of Singapore. GIC invests internationally in public equities, fixed income, real estate, private equity and infrastructure assets.

As Chief People Officer since 2017, Ms Ong oversees human resource strategy and group finance for enterprise performance and talent with the right values and culture. As a member of the Group Executive Committee, her focus areas include leadership development, reward and organization strategies for business effectiveness. As Company Secretary, she oversees Corporate Governance and Client relations.

Ms Ong was previously Director Finance from 2009 to 2014, where she headed the Finance Group responsible for financial management across the GIC portfolio, tax planning, investment holding structures, and management of group revenue and expenditure.

Prior to GIC, she was a Tax Accountant with Arthur Andersen. She holds a Bachelor of Accountancy from the Nanyang Technological University of Singapore, and completed the Stanford Executive Programme. Ms Babbage is a highly experienced financial services professional with a 20-year investment banking career spanning both international and domestic financial and commodity markets. She joined Deutsche Bank Australia in 1997 as a Commodities Derivatives Trader and from 2000 to 2011 was Managing Director holding the portfolios of Asia-Pacific Head of Commodities, Head of Foreign Exchange and Head of Global Finance & Foreign Exchange. Ms Babbage served as a Global Executive Committee member of several capital markets business lines, spending significant time in London, New York and Singapore, aside from Sydney. Prior to joining Deutsche Bank, Ms Babbage worked as a trader with Bankers Trust Australia.

Ms Babbage has served as a member of the Board of Swiss Re Life & Health Australia Limited, where she was also the Chair of the Audit Committee and a member of the Risk Committee and Remuneration Committee.

Ms Babbage is a non-executive director of Nippon Life Insurance Australia and New Zealand Pty Ltd, Resolution Life NOHC Pty Ltd and 1941 Capital Pty Ltd. She is also a member of the Ord Minnett Private Opportunities Fund Investment Committee. She has previously served on various boards in the health and finance sectors including Swiss Re's USA entities, Q Super Ltd (and Q Invest Ltd.), a not-for-profit superannuation fund based in Brisbane, Queensland, Mercer Investments Australia, St Vincent's Health Australia and IOOF Foundation in Australia as well as the University of NSW US Foundation.

Mr Torben Thomsen was elected to the Board of Directors of Swiss Re Asia Pte. Ltd. on 8 February 2022. He is also the Chair of the Finance & Risk Committee and a Member of the Audit Committee albeit as an external, non-executive director with effect from 1 July 2024.

He has served as Swiss Re Group's Chief Risk Officer Reinsurance until March 2023 and was Senior Advisor, Risk Management Advisory and Underwriting Operations, until his retirement in June 2024.

Mr Thomsen has over 30 years' experience in global reinsurance with more than 20 years of experience in senior leadership positions managing global and regional teams across multiple locations and continents. He began his career as a pricing actuary with Nordisk Re (later GE Insurance Solutions) in Denmark. He has managed various roles in GE Insurance Solutions including Head of its Continental Europe Life & Health Business, Executive for Sales and Pricing in the London office and Leader of the Life & Health department in Copenhagen.

He joined Swiss Re following the acquisition of GE Insurance Solutions in June 2006 and was appointed the Chief Pricing Officer for Life & Health Products. From 2014 to 2018, he was appointed as the Chief Risk Officer Reinsurance EMEA & Head Risk Management Reinsurance Life & Health and in July 2018 he was appointed the Chief Risk Officer Reinsurance.

Mr. Alan Wilson was elected to the Board of Directors of Swiss Re Asia Pte. Ltd. on 1 August 2024 and was appointed as a member of the Audit Committee effective 1 April 2025.

Mr. Wilson is an insurance industry veteran with 45 years of extensive experience in senior management roles and board positions, particularly in Asia. He joined MSIG Asia in 2008 as the company's Chief Executive Officer and remained in the role for 14 years. Mr. Wilson also served as a director on multiple MSIG-related corporate entities around the region and led the expansion of the MSIG network in Asia to over 14 markets. Prior to joining MSIG Asia, Mr. Wilson was the Asia CEO at Allianz Group from 1999 where he assumed the overall responsibility for managing over 20 general, life and health insurance operations across 14 countries, and later served on several boards for Allianz and for other corporate groups such as Parkway in Asia.

Mr Malmström joined Swiss Re in January 2025 and was appointed Group Chief Financial Officer and Member of the Group Executive Committee effective April 2025.

Mr Malmström started his career in 1997 as a project manager and team leader at Swiss Life in Zurich, subsequently becoming Head Product Development Group Life. He joined AXA Winterthur in 2009 as Head of Group Life and was a Member of the Executive Board, moving on to the position of Head of Life a year later.

Mr Murray joined Swiss Re in 2003 as a Marketing Actuary, and was appointed as Managing Director, Head of Life & Health Products, UK, Ireland & Africa in 2006. From 2010 to 2014, he held the position of Managing Director, Head of Life & Health Products, Asia, while based in Hong Kong.
