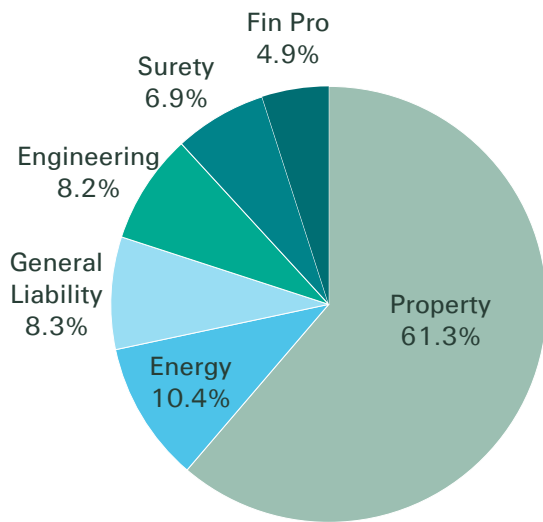

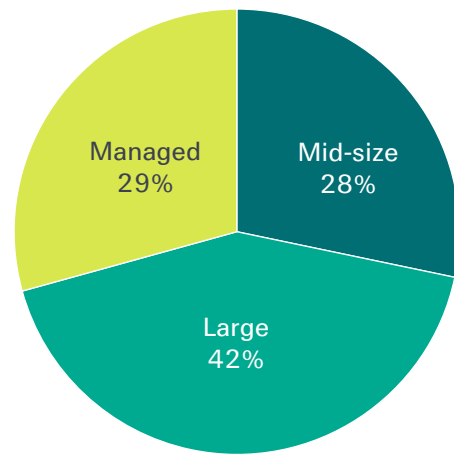

Premium by line of business

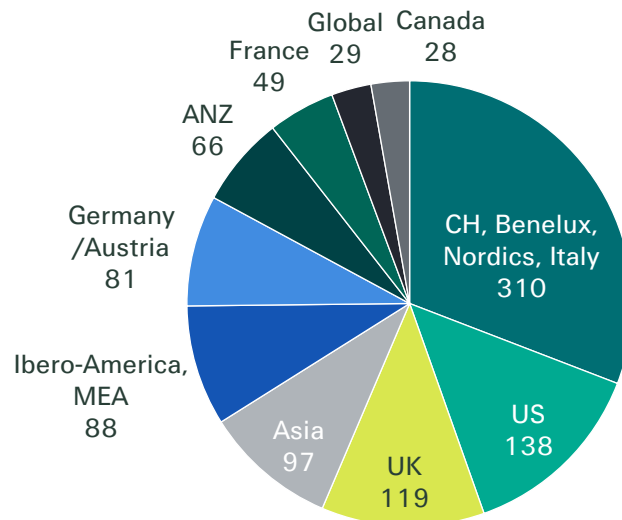


Premium by company size

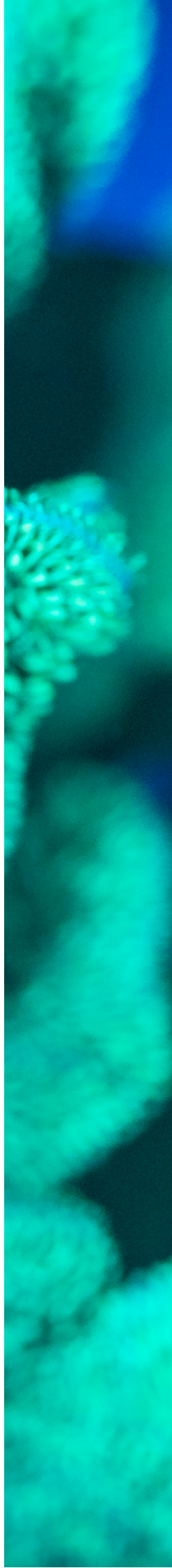

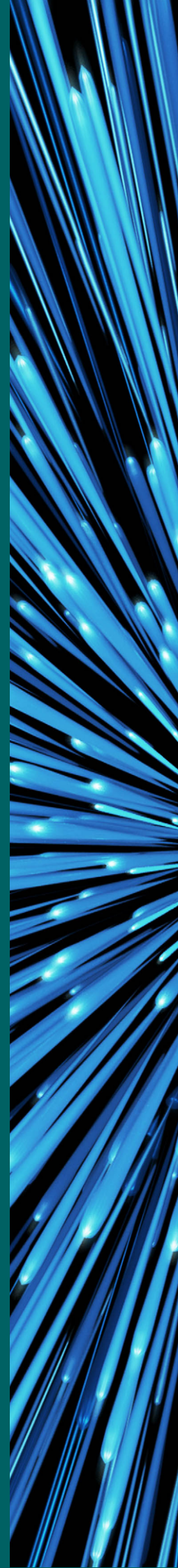
